**A RESOLUTION OF THE TICE FIRE PROTECTION & RESCUE SERVICE DISTRICT, LEE COUNTY, FLORIDA, ADOPTING THE FINAL MILLAGE RATE LEVY OF AD VALOREM TAXES FOR SAID DISTRICT FOR FISCAL YEAR 2022-2023; PROVIDING FOR SCRIVENER'S ERRORS; PROVIDING FOR CONFLICTS: PROVIDING FOR LIBERAL CONSTRUCTION; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.**

WHEREAS, the Tice Fire Protection & Rescue Service District ("District") was established by the Florida Legislature pursuant to Chapter 2000-438, Laws of Florida; and,

WHEREAS, the District has noticed and held its public hearing to set the final millage rate for the 2022-2023 fiscal year on Wednesday, September 21, 2022 at 5:30 p.m.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE TICE FIRE PROTECTION & RESCUE SERVICE DISTRICT that:

**SECTION 1. INCORPORATION OF RECITALS**

The recitals set forth above are true and correct and form a part of this Resolution.

**SECTION 2. FINAL MILLAGE RATE ADOPTION**

Pursuant to Florida Statute Section 200.065, the Board of Commissioners of the Tice Fire Protection & Rescue Service District hereby adopts and sets the final operating millage rate of 3.75 mills for the fiscal year 2022-2023, which begins on October 1, 2022, and ends September 30, 2023. The above stated millage rate of 3.75 mills exceeds the rolled back rate of 3.30 mills by 13.44%.

**SECTION 3. RESCISSION**

The Board of Commissioners hereby rescinds all prior resolutions and other official actions of the Board of Commissioners to the extent of any conflict with any part of this Resolution.

**SECTION 4. APPLICABILITY AND EFFECTIVE DATE**

This Resolution shall be liberally construed to implement the purposes hereof and shall take effect immediately upon this Resolution's adoption.

**SECTION 5. SEVERABILITY**

If any provision of this Resolution is held to be illegal, invalid or unenforceable under any law or court of competent jurisdiction, the remaining provisions of this Resolution will remain in full force and effect and will not be affected by the illegal, invalid or unenforceable provision or by any such severance.
